- 4 The Company's Operations fall under two segments namely "Making of Machineries relating to Diomand Business and related service" and "Trading in Diamonds"

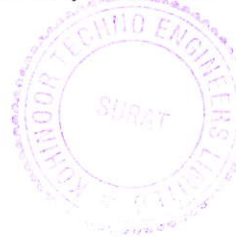

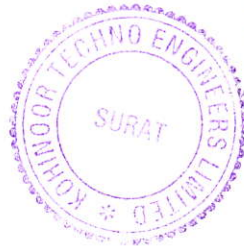
